i. <u>To consider donation to Oakley Cross and Copeland Road Schools</u>

Following consideration it was agreed that each of the schools would be given $\pounds 100$ towards the individual fundraising targets.

ii. <u>To consider speed warning quotes and agree progress</u>

Cllr Smith advised that he has obtained various quotes for speed warning signs. Following consideration it was agreed that SID signs be approached for definite price including any discount for purchase of 2 or more. ACTION: Clerk to request approval and request input on the most suitable site. It was also requested that the 30 mph sign at the top of Copeland Road be relocated ie. Minimum 100 yards outside of residential area.

i <u>To consider reverting Pant slip-road back to village green</u>

Following consideration it was agreed that this item be prioritised once an indication of the actual cost is obtained. ACTION: Clerk to follow-up with Bryan Harris and Cllr Robinson to obtain quote.

ii <u>To consider setting up village archive group</u>

Cllr Roberts agreed to provide an article for inclusion in the next agenda. The Clerk requested that other options of promoting this item also be considered as response to newsletter articles is usually poor. ACTION: Cllr Roberts to provide an article.

iii <u>To consider prevention of cold callers</u>

The possibility of preventing cold callers was considered and it was agreed that Neighbourhood Watch should be approached for advice on implementing this initiative. It was highlighted that not everyone may wish to prevent cold callers and therefore residents should be given the option. ACTION: Clerk to contact John Raw.

iv Spring Clean 2014

Various ideas were raised about engaging the local community in the Spring Clean initiative. Cllr Roberts agreed to contact the Spring Clean organisors to obtain dates which coincide with events in neighbouring areas and seek their input on the criteria for involving school children. ACTION: Cllr Roberts to contact Spring Clean organisors.
