25.81TO RECEIVE NOMINATION FOR CHAIR AND APOLOGIES FOR ABSENCE

25.82 DECLARATION OF INTEREST IN ITEMS ON THE AGENDA

25.83 To Confirm Minutes Of Previous Meeting

The Minutes of the previous meeting were agreed and signed accordingly.

25.84 TO Invite Any Comments From Members Of The Public

- Thanks were given to Cllr Billy Robinson and Cllr Neil Simpson for their support with installing the stone trough behind the Pant and reducing the height of the 3-tier planter.
- Concerns were raised about youths throwing water bombs and giving racist verbal abuse to a village visitor who was staying at the Manor House hotel for a spa break. The resident advised that she has personally written to Joy Allen, Police and Crime Commissioner, requesting more police support in West Auckland. The resident requested details for Sam Rushworth, MP to raise concerns. It was agreed by Parish Councillors that the problems with youth anti-social behaviour is becoming worse. It was highlighted that younger children are being influenced by older ring leaders. The Parish Council agreed to also send a letter of concern to Joy Allen, PCC.
- Cllr Nick Brown advised that most of his emails are from residents with concerns about anti-social behaviour in West Auckland and Cllr Stephen Gray has written to Joy Allen. It was agreed that drones, training and CCTV will help provide the police with information that they need.

• It was highlighted that when the miner sculpture was criminally damaged the police were given information about the one of perpetrators by an eye-witness, the police follow up was slow due to shifts; an update from the police is expected at the next PACT meeting.

25.85 To Receive Councillors' Reports

- It was advised that 2,000 daffodils will be planted alongside the Leech estate wall adjacent to the A68.
- It was reported that the miner sculpture, damaged by 3 youths, has been repaired and will be reinstalled this week. Thanks were given resident Steven Robinson and Cllr Billy Robinson for their efforts in repairing the sculpture.
- Cllr Stephen Gray provided an update on the current progress with the plans for a Toft Hill bypass. It was advised that there are five options being considered and an impact assessment process is currently being carried out. A decision will be made, funding dependent, by the end of this year whether the proposal for a Toft Hill bypass will proceed. It was advised there was no mention of West Auckland being considered for inclusion. It was suggested by Cllr Roberts that a separate meeting could be arranged to provide the new County Councillors with some background. Cllr Brown advised he has always been in support of a West Auckland bypass.
